

**THE VERIZON 4 NATIONS FACE-OFF™ SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE OR CONSIDERATION NECESSARY TO PARTICIPATE, ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

SPONSOR: Verizon Corporate Services Group Inc., One Verizon Way, Basking Ridge, New Jersey 07920 (the “Sponsor”).

SWEEPSTAKES PERIOD: The Verizon 4 Nations Face-Off™ Sweepstakes (the “Sweepstakes”) begins at 12:00:01 AM Eastern Time (“ET”) on January 24, 2025 and ends at 11:59:59 PM ET on February 5, 2025 (the “Sweepstakes Period”).

ELIGIBILITY: The Sweepstakes is open to legal residents of the 50 United States and the District of Columbia who are eighteen (18) years of age or older and the age of majority in their state of residence at the time of entry. Void outside the U.S. and wherever else prohibited by law. Employees, officers, directors, agents and representatives of the Sponsor, Sweepstakes Administrator, NHL/NHLPA Entities (defined below), and their respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter. Sweepstakes is subject to all applicable federal, state and local laws and regulations.

Limit: One (1) Entry per person regardless of whether entrant has more than one email address. Although subsequent attempts to enter may be received, only the first complete Entry received from a particular entrant will be eligible; subsequent attempts by the same person to enter, including Entries submitted with an alternate email address, will be disqualified. All Entries become the property of the Sponsor and will not be acknowledged or returned.

PRIZES/APPROXIMATE RETAIL VALUE (“ARV”)/ODDS:

Grand Prize: There are four (4) Grand Prizes (each, a “Grand Prize” and collectively, “Grand Prizes”) available to be won. Two (2) Grand Prize winners will receive a trip package for two (2) people, Grand Prize winner and one (1) guest (the “Guest”) to Boston, MA for the USA versus Sweden hockey game on February 17, 2025 (“Trip One”). Two (2) Grand Prize winners will receive a trip package for two (2) people, Grand Prize winner and one (1) Guest to Boston, MA for the 4 Nations Face-Off™ Championship hockey game on February 20, 2025 (“Trip Two”). Winners will be selected at random and do not have the option to select which game they would like to attend.

Each Grand Prize includes:

- Round-trip, coach-class air transportation for winner and Guest to Boston, MA from a major airport within the United States nearest the winner's residence as determined by Sponsor.
- Two (2) nights hotel accommodations in Boston, MA based on single room / double occupancy.
- Two (2) tickets ("Tickets") to either the February 17, 2025 or February 20, 2025 hockey game.

The ARV of each Grand Prize: \$2,660 USD. The ARV may vary based upon point of departure. The difference between the ARV and actual value of the Grand Prize will not be awarded. In the event the Grand Prize winner or Guest engages in behavior during travel that (as determined by Sponsor in its sole discretion) is illegal, tortious, or subjects winner or Guest to arrest or detention, Sponsor shall have no obligation to pay any damages, fees, fines, judgments or other costs or expenses of any kind whatsoever incurred by winner as a result of such conduct. **SPONSOR AND RELEASED PARTIES SHALL HAVE NO LIABILITY FOR ANY PERSONAL INJURIES, DEATH, PROPERTY DAMAGE, OR OTHER DAMAGES OR EXPENSES RESULTING FROM OR ARISING OUT OF ANY TRAVEL RELATED TO THE GRAND PRIZE OR ANY OTHER ASPECT OF GRAND PRIZE WINNER'S AND GUEST'S ACCEPTANCE OR USE OF THE PRIZE.**

The total ARV of all prizes available to be won: \$10,640 USD.

Odds of winning will depend upon the total number of eligible Entries received.

WINNER NOTIFICATION & VERIFICATION: The potential Grand Prize winners will be notified via email or phone and will be required to respond within twenty-four (24) hours of the initial notification attempt. DISPUTES: The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the state and federal courts in Basking Ridge, New Jersey and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in Somerset County, New Jersey. The federal or state law that applies to these official rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in Somerset County, New Jersey. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.

PRIVACY: As a condition of entering the Sweepstakes, each entrant gives consent for Sponsor to obtain and deliver his or her name, address and other information to third parties, including Sweepstakes Administrator, for the purpose of administering this Sweepstakes and to comply with applicable laws, regulations and rules, including, without limitation, the storing of your personal information for purposes of complying with state record retention requirements.
